They can help determine:

- the appropriate gift level for each beneficiary
- the type of gift to make:
 - a specific sum
 - all or part of a particular asset such as property, shares or insurance policy
 - a proportion of your estate, or
 - all or part of the residue of your estate, the remainder after all testamentary expenses and specific bequests (gift) to named beneficiaries (eg family) have been paid.
- the tax implications of your gift, e.g. capital gains tax on investment property and stocks and shares
- how to best structure the gift to each beneficiary
